1. Detailed industry-standard production budget and top sheet. Must include closed captioning and described video.
2. Proposed shooting and production schedules.
3. Script, detailed outline or treatment, including a description of the subject matter as well as the filmmaker's editorial and cinematic approach
4. Detailed one-page project synopsis.
5. Written commitment from a qualifying platform
 - broadcast commitments must guarantee a prime time broadcast within two years of delivery
 - online platform commitments must guarantee availability of the production on that platform within two years of delivery
 - broadcast commitments must include the broadcaster performance envelope commitments, if applicable.
6. Evidence of relevant deferral, service and/or equity arrangements.
7. Proof of committed financing to date.
8. Detailed financing plan.
9. Resumes and background information on producer(s) and key creatives, including screenwriter and director
10. If re-applying with a project, please identify any significant changes to the financing and/or creative materials from the previous application.
